This may include (but is not limited to): Material changes are made to the design or distribution of the product, including related documentation; legislative or regulatory changes; significant or systemic complaints or claims issues are apparent that indicate that the suitability of the product to the target market has changed; distribution conditions found to be inadequate; external events such as adverse media coverage or regulatory attention; customer dissatisfaction; Poor or significantly deteriorating key product suitably metrics, including: o Complaints monitoring o Net Promotor metrics o Product value metrics o Financial performance metrics; and Feedback from a regulator, the Private Health Insurance Ombudsman (PHIO) or Australian Financial Complaints Authority (AFCA) which suggest this TMD is no longer appropriate.
